3. Financial Report from the Executive Director

- Expenses for September were relatively low- reserving the BMX Company for Dropped 2024 was the biggest expense.
- b. The BIA is expecting the remainder of the 2023 levy funds to arrive to the bank account in the coming weeks.

4. **2024 Budget Draft- ED**

- a. Adding hydro outlets to light poles is no longer a feasible option after Shane met with the City to talk through options. The money set aside in the budget for that expense has been removed from the draft.
